## Board of Selectmen Approve Municipal Budget below LD1 Limit

At the March 22, 2007, meeting of the Raymond Board of Selectmen, the proposed 2007-2008 fiscal budget for the Town of Raymond was approved by the Board of Selectmen, subject to final adoption at the May 19 Annual Town Meeting, at a net increase of \$57,113, or 3.23% over last year. The presented Municipal budget total of \$1,824,398 is \$4,212 less than that allowed by LD1 for fiscal 2007-2008.

In the beginning of the budgeting process, the Board of Selectmen established several performance guidelines and goals to be met by the Town Manager in preparing the budget. Among these goals were increasing the appropriation for capital road improvement work, maintaining the current curbside waste collection system, and exploring the sharing of services with neighboring towns and/or Cumberland County government to reduce costs and maintain or improve services. In addition, the Board of Selectmen expressed continued support of the Raymond Waterways Protective Association and the Raymond Village Library. Mindful that the majority of Raymond residents voted for the passage of TABOR, they also mandated that the budget come in within the constraints of LD1.

The Town's department heads were instructed to comply with the Board's wishes, and presented requests to the Town Manager

resulting in a gross budget increase of only .75%, or \$27,654, over last year's gross municipal budget. Due to expected reductions in revenues, particularly from excise tax and Municipal Revenue Sharing, the budget had to be finely tuned to achieve the desired goals, but the proposed budget is successful in meeting them.

Among the goals achieved in the proposed budget are: an increase of \$40,000 in the appropriation for capital road improvement work; a reduction in the cost of dispatch services by combining with the Town of Naples; appropriating funding requests by the Raymond Waterways Protective Association and the Raymond Village Library; a new contract with Pine Tree Waste for trash and recycling curbside pickup; and a slight reduction in the use of undesignated funds. The budget also includes an appropriation for a new voting machine to replace the present 20-year old machine, and the replacement of the windows in the main part of the Town Hall.

Although not included in this proposed budget, the Town is seeking private sector insurance bids in an attempt to further reduce costs in the future.

As presented, the 2007-2008 budget seeks to maintain the current mil rate of \$10.20 per thousand, while maintaining or improving services to the community.

YOU CAN STILL RUN FOR OFFICE, if you have your nomination papers deposited in the Town Clerk's Office no later than Wednesday, April 4, 2007, at 4pm. Pick up a nomination form at the Town Clerk's Office during regular business hours and obtain not less than 25 nor more than 100 signatures.

The 2007 Annual Town Meeting will begin on Friday, May 18th, with the election of 2 Selectmen, 1 School Board member, and 3 Budget Finance Committee members. The polls will be open from 7am until 8pm at the Jordan-Small Middle School gymnasium.

The open Town Meeting will be on Saturday, May 19th, convening at 10am at the Jordan-Small Middle School gymnasium. The Raymond Village Library will be selling various delicious lunches for your pleasure and convenience. The Town Reports should be available by May 1st. They can be picked up at the Town Office, Clough's Store, Sunset Variety, Hilltop Market, the Raymond Village Library and Community Pharmacy.

## **Municipal News Brief**

The Raymond Board of Selectmen recently took the following actions:

#### **Tuesday, February 20, 2007**

- 1) Broadcast studio update/presentation of certificates of appreciation – Chairman Board of Selectmen Mark Gendron

Certificates of community appreciation were awarded by the Board of Selectmen to former Selectmen Ada Brown and Betty McDermott, as well as Network Administrator Kevin Woodbrey, Vice Chairman of the Board of Selectmen Mike Reynolds, and Town Manager Don Willard, for their leadership and work in the creation of the digital broadcast studio.

- 2) Data services discussion – Network Administrator Kevin Woodbrey

Network Administrator Kevin Woodbrey provided an open document format (odf) presentation outlining issues related to work necessary to create a relational database for the town's five different network servers. These servers, which contain a great deal of overlapping information within their databases, have to be kept in alignment in order to provide up-to-date information for use by town departments and the public. Currently much of this update work is manually done on each database. After the presentation the Board of Selectmen authorized using existing funding to hire a consultant to assist with the transition from the present system to a system that will push updates out to the proper servers as created by each individual department. This change will save a good deal of future effort by eliminating repetitive data entry.

- 3) Regional dispatch center technical review – Network Administrator Kevin Woodbrey

Network Administrator Kevin Woodbrey provided a technical and operational review of both the Naples and Windham communication centers as a possible future location for a regionalized service, including Raymond. Previously the town had received a presentation from Cumberland County. Although both Cumberland Coun-

ty and Windham currently have technical advantages and cost savings advantages over the Naples dispatch center, the potential to custom tailor service in Naples and to have an active role in future decision making, influenced the Network Administrator and Fire Chief to make a recommendation for a one year trial period with Naples for public safety emergency dispatch. The Town of Raymond will provide technical support to Naples in setting up equipment and software for this regional effort. It is hoped that by working closely with the member towns of the Naples center (Harrison, Sebago, Casco and Naples) future cost savings opportunities could also be realized. After the one year trial period, an evaluation will be made to determine whether significant progress has been made in this area or whether all the options for dispatch services should be re-evaluated. The objective of moving the dispatch center from Raymond is to take advantage of the cost savings of working on a joint basis to provide these services, while at the same time not suffering any decrease in the quality of the service. Examples of areas of future cooperation include shared fire department operations and multi-town participation in the start up paramedic "fly car" program currently being developed by Fire Chief Denis Morse and EMS Director Cathy Gosselin.

- 4) Consideration of abatements – Contract Assessor Mike O'Donnell, O'Donnell & Associates

a) None

- 5) One Raymond Committee Update – Mark Gendron & Dana Desjardins, Co-Chairs

a) Next One Raymond Committee to be held on March 1, 2007.

- 6) Discussion of printing costs for this year's town report – Town Clerk Louise Lester

The Board of Selectmen considered the potential of printing all of the Land Use Ordinance amendments in the town report this year versus producing this material in-house as a separate document, given the much larger volume of material. It was decided that the town clerk should bid the printing both ways and that a decision would be made at the next meeting as to whether the town report would be printed with all the land use amendments included or as a standalone document.

- 7) Old (unfinished) business.

a) Discussion of possible replacement of heavy duty plow truck – Public Works Director Nathan White

A motion was made and unanimously approved to purchase a 2006 International heavy plow truck to replace the town's 1995 GMC truck, as had been planned in next year's capital budget. The decision to purchase the truck early was to take advantage of substantial capital acquisition and operational savings before new federally-mandated emissions standards are imposed upon 2007 vehicles.

b) Determination of 2007 town scholarship award levels – Town Clerk Louise Lester

This item was tabled in order to allow the town clerk to provide additional information on interest earned for the various scholarship accounts.

- 8) Town Manager Report and Communications.

a) The town manager reported that roads will be posted prohibiting heavy truck traffic beginning on March 5, 2007, and running through May 31, 2007.

b) The Board of Selectmen signed a Quit Claim deed to release the town's interest in the Waterman property at 25 Shaker Woods Road. All interest, penalties, delinquent taxes and associated administrative charges have now been paid in full.

- 11) Fiscal Warrants – Payroll and Appropriation Warrants – February 20, 2007.

Approved payroll and appropriation warrants dated February 20, 2007.

#### **Tuesday, March 6, 2007**

- 1) Resignation of Allen Tait from Planning Board

The Board of Selectmen accepted the resignation of Planning Board member Allen Tait with regret and thanks for his volunteer service to the town.

- 2) Interview two applicants for the open seat on the Plan-

ning Board – Board of Selectmen

With the resignation of Mr. Tait, an opening for a full member of the Planning Board was created. Interested citizens Christina Keilt and Greg Foster were interviewed by the Board of Selectmen. Both candidates were exceptionally well qualified for the position, with Greg Foster receiving the nomination and approval of the board to fill the open seat. Christina Keilt was asked if she would consider a position as a member of the Comprehensive Plan Implementation Committee, which she accepted. She was subsequently nominated and unanimously approved to serve the town in this capacity.

- 3) Fire/Rescue Budget overview/update – Fire Chief Denis Morse

Fire Chief Morse provided an overview of the fiscal year 2007/2008 Fire Rescue Budget with an emphasis upon explaining the process by which he has budgeted for and secured fixed departmental capital assets. He also explained the underlying philosophy and cost savings work necessary to hold his budget at a zero increase over the last three years. He thanked his departmental members and town administration for the cooperation that he had received in being able to achieve this accomplishment. He then discussed his desire to sign a one-year contract with the Naples dispatch center for Fire/Rescue dispatch services, commencing full-time in October 2007. Raymond will participate actively with our neighboring communities in building a regional dispatch center that will retain the services and qualities of the present Raymond center, but at the same time offer the cost-of-operations advantages that can only be obtained by working cooperatively with neighboring communities. The dispatch arrangement will be for a one year trial period only and will commence on a part-time basis as soon as practicable for overnight coverage. EMS Director Cathy Gosselin reported on the staffing and activities of the town's volunteer rescue service. Noting that there are about thirty people in the Fire Rescue department, with approximately twelve members doing fifty calls each annually. She also highlighted the work that is done by volunteers to maintain the Public Safety Building and perform other related duties such as Fire Police work. Ms. Gosselin explained a new program that is under development with other area towns to provide improved paramedic coverage by utilizing a shared paramedic "fly car". This vehicle would be municipally owned and would be stocked with emergency equipment and medicines in order to allow the paramedic to respond more quickly and then decide whether additional assistance and/or ambulance transportation was needed. Similar programs have been successfully in place in other communities in Maine for some time. At the conclusion of the Fire Rescue presentation, a motion was made to approve a one-year contract with Naples for full-time dispatching services commencing in October 2007.

- 4) Discussion on possible warrant article to change the date of town meeting – Town Clerk Louise Lester

The Board of Selectmen had a preliminary discussion with the town clerk about the legal ramifications of a possible change in the date and form of town meeting. The town clerk will gather additional information for discussion at the Board of Selectmen's March 22nd meeting, to be held at the Broadcast Studio.

- 5) Capital planning and asset acquisition policy discussion – Selectman Joe Bruno

Selectman Bruno felt that the town's current policy could be greatly improved if a formal policy outlining capital purchasing and debt were implemented. He suggested that it may make more sense for the town to maintain a single Capital Improvement Program (CIP) reserve fund for certain purchases and to bond for other purchases as necessary, given the historically low rates of interest communities typically pay to bond for capital improvements. An additional concern is that the town should have an "Undesignated Fund Balance Use Policy," governing the levels at which the fund balance should be maintained and the specific purposes to which the fund balance could be utilized if it exceeded established minimum levels. The town manager was instructed to get additional information on such policies from other communities for future consideration.

- 6) New town office concept vote discussion – Selectman Joe Bruno

Selectman Bruno felt that before any additional development money was expended on investigations regarding a possible new town office a presentation should be made to Annual Town Meeting and a concept or "straw" vote obtained as to whether the voters of the town wanted to continue said investigations. An affirmative vote on such an article could, after sufficient funding is established at a future town meeting, lead to an actual proposal to be considered by the townspeople for a new or renovated building. On the other hand a negative vote would focus work on renovations and continued use of the existing building. There was also some discussion over the building needs of the library and whether it made more sense to attempt to work together or independently to meet each entity's respective needs. The town manager was instructed to draft a warrant article for Selectmen consideration that would enable the townspeople to have a conceptual or "straw" vote on additional town office study at this year's Annual Town Meeting.

7) Consideration of abatements – Contract Assessor Mike O'Donnell, O'Donnell & Associates

The Board of Selectmen considered and approved eight abatements as recommended by Mr. O'Donnell.

a) Discussion of printing costs for this year's town report – Town Clerk Louise Lester

The Board of Selectmen, upon reviewing competitive bids received from four vendors, elected to print the entirety of the proposed Land Use Ordinance revisions in the annual report, as has been the custom of the town in years past. This year's report will be not more than 177 pages in length and will be printed by Maine Label & Printing, for a total cost not to exceed \$3,553. The motion to award the printing bid was unanimously approved.

b) Determination of 2007 town scholarship award levels – Town Clerk Louise Lester

A motion was made and approved unanimously to fund the following scholarships for 2007: Carleton E. Edwards - \$500; Alvah Clough – none; Torstein Johannas Lund – none; George E. Woods - \$1,000; Collins-Day - \$1,500; for a total of \$3,000.

1) Request for warrant article approval for Annual Town Meeting regarding proposed zoning map and proposed ordinance revisions – Chairman Pat Clark and Town Planner Hugh Coxe, Planning Board and Comprehensive Plan Implementation Committee

CPIC member and Selectman Mike Reynolds introduced this item and told the Selectmen that the proposed Land Use Ordinance revisions will be ready as planned for consideration at Annual Town Meeting on May 19th, but that the zoning map will have to wait for future town meeting consideration as it is not yet ready.

2) Consideration of town manager proposed fiscal year 2007/2008 budget – Town Manager Don Willard

The Town Manager and Finance Director answered questions regarding the proposed fiscal year 2007/2008 municipal budget. The Board of Selectmen reviewed the budget and warrant articles as they will appear at Annual Town Meeting. One budget change was made with the addition of an appropriation of \$1,000 to support the work of the Greater Bridgton Lake Region Chamber of Commerce. This revision was made after GBLRCC Executive Director Mike McClellan asked for reconsideration of the Chamber's funding request. Other adjustments in the warrant included an increase in the article that authorizes expenditures from surplus for unanticipated issues throughout the year from

\$50,000 to \$75,000. The Selectmen also elected to put a "sentiment" article on the warrant to gauge voter interest and support for possible exploration of current and future space needs related to a possible new or renovated town office. This exploratory article will ask for an appropriation of \$10,000 from surplus. After the budget review was concluded, the Board of Selectmen thanked all involved staff for adhering to the guidelines established at the outset of the budget development process and for a job well done. The Board of Selectmen's proposed 2007/2008 municipal budget now reflects a gross increase of .75 % or \$27,654. It is the goal of the Selectmen, after combining the municipal budget with requests from the school and county, to hold the current tax rate at its present level of \$10.20 per thousand valuation.

3) Consideration of 2007 Dog Warrant – Town Clerk Louise Lester

The Town Clerk presented the 2007 dog licensing warrant, which showed that as of March 14th, one hundred and two previously licensed dogs had not been licensed for 2007. By executing the dog warrant, the Animal Control Officer is instructed to give warning to these dog owners to license their dogs or face a summons as authorized and required under Maine law M.R.S.A. Title 7 § 3943.

4) One Raymond Committee Update – Mark Gendron & Dana Desjardins, Co-Chairs

a) The next meeting will be April 19, 2007.

5) Old (unfinished) business.

a) Discussion on possible warrant article to change the date of Annual Town Meeting and the possibility of using referendum voting – Town Clerk Louise Lester

Town Clerk Louise Lester introduced this item with an overview of the legal and procedural requirements in order to change the date of the town meeting and to consider referendum voting. It is within the authority and power of the Selectmen to set the date of the town meeting, as well as the form of the vote. The Selectmen after considering this, and given the short timelines to this year's Annual Town Meeting, elected to offer the voters an opportunity to consider an alternate voting time that would correspond with most area towns and other elections, such as the Portland Water District. This revised date would call for an early June meeting and would also give the voters the opportunity to elect to approve both the town and school budget through a referendum style vote. The primary advantage of a referendum vote is that the voter turnout would be significantly higher than that obtained through an open oral town meeting. The principal disadvantage is that debate and discussion over the budget would not occur in the open town meeting setting. In order to address this concern, the town would hold an annual budget hearing so that citizens could have a voice in the budget decision-making. Both the question of the timing of the town meeting and the form of meeting will be offered to the voters at this year's Annual Town Meeting for consideration. This input of the voters is being sought since the town has, over the past twenty years, changed the date of the Annual Town Meeting on at least three occasions between March and May.

6) Town Manager Report and Communications.

a) The Town Manager highlighted a new feature for the Road Runner, written by Executive Secretary Laurie Cook, to provide information to citizens on the activities of the Raymond Public Works Department.

b) The Town Manager also told the Selectmen that it appears that the Town of Naples will be adopting the partial pay-as-you-throw bulky waste program initiated by Raymond two years ago. This program has resulted in significant savings to the town by eliminating large quantities of bulky waste being delivered to the facility by a relatively small number of residents. Under the program, residents are allowed 1,000 pounds of delivered bulky waste at town expense, with additional waste paid by the individual according to the facility cost schedule.

7) Fiscal Warrants – Payroll and Appropriation Warrants – March 22, 2007.

## PTO Scholarships

The PTO gives two \$1000 college scholarships every year to high school seniors who meet specific criteria in terms of community involvement, academics, quality & content of an essay, and personal recommendations. We have often felt that we were missing students who showed real promise and had a definite financial need, but for various reasons were unlikely to compete with other students based on the above-mentioned criteria. We decided to create a special \$1000 scholarship to provide financial support to a needy student who might not meet the criteria of our conventional scholarship, but who had overcome significant barriers in his/her personal life and had sought to further his/her education. Unlike our standard scholarship, the Julie Orsini Memorial Scholarship may be granted more than once to a deserving student over the course of his/her post secondary education.

## Fire-Safe Cigarettes

Many states have already passed a law that requires special cigarette paper to be used when making cigarettes.

Recently my committee, the Criminal Justice and Public Safety Committee, heard a bill, which if passed, would require that beginning on January 1, 2008, all cigarettes sold in Maine must be what is known as "Fire-safe." Specifically a Fire-safe cigarette is one where the paper used to make the cigarette has a limited amount of burn time unless actually being smoked. This special paper contains two barely visible separate sections made into the cigarette paper that will not burn, and therefore, the cigarette will extinguish by itself unless it's being "dragged on" when the burn reaches these parts of the paper.

Extensive research throughout the country has shown that many house and apartment fires are started by people falling asleep while smoking in bed or sitting on a sofa or upholstered chair. When cigarettes are dropped or fall on a sofa type piece of furniture, tests have shown that it usually takes nearly one half hour for the cigarette to actually ignite into a fire or heavy smoke. Fire-safe cigarettes self extinguish before the time it would take for furniture to ignite, and thus fires that could result in loss of life and property can be prevented.

Some people have questioned why we have to go such an extent just to protect people from themselves, i.e., those who lack the common sense not to smoke in bed or in similar situations. The Maine State Fire Marshall testified before our committee that oftentimes many innocent people are injured or die as a result of someone starting such a fire. Therefore, there are many other aspects to consider.

This bill was also supported by the tobacco industry and was enthusiastically supported by some Maine businesses like distributors, for instance, who deliver these products to the hundreds of stores and other locations where cigarettes are sold. In fact, there was no opposition to the final version of the bill, which was also supported by the Maine Lung Association. We learned that three other New England states have already passed this new "fire-safe" cigarette law, and two others are actually in the process of doing so this year.

The tobacco companies have testified that there will be no additional cost to the consumers, so given all of the support the committee heard, it appears that this bill will fly through the legislative process quite easily.

Any comments or thoughts you may have would be helpful to me.

Our own Sebago Lake covers an area of 28,771 acres with a depth in some locations of 316 feet and the average depth of 150 feet. It is the second largest lake in Maine and the third largest lake in New England.

## Fire/Rescue Dispatch Asks Your Help

When you lose your dog or cat, you can call Dispatch and ask them to notify Don Alexander, our Animal Control Officer. When you lose your horse, llama, or cow, it's a bit more involved since they won't fit in an animal carrier. The place to call is Dispatch, but more information is necessary in order to rescue your livestock.



We are asking that you fill out a Livestock Location form for

Dispatch's use. If you have already filled one out, please review it so that the information is current. The forms can be obtained at Dispatch in the Public Safety Building, 1443 Roosevelt Trail; the Town Office; or online at Raymond's website [www.raymondmaine.org](http://www.raymondmaine.org).

These forms are most important in order to better identify the horse(s) running down the road or the llama visiting someone's backyard. It's for the safety of the animal and the person who might hit it with his car.



### 2007 Dog Registration

Dog licensing was due January 31st. If you have a dog over the age of 6 months, it should be licensed. A Rabies Certificate must be produced and if neutered, a Neutering Certificate, if the Town Office does not have it on file. The fee for a neutered dog is \$6 and non-neutered is \$10. For dogs licensed in Raymond in 2006 but not yet in 2007, after April 1st there will be an additional \$25 late fee.

Please understand that by having your dog licensed, anyone finding your stray pet will be able to trace it to you thereby alleviating the possibility that it will go to a shelter. Licensing funds contribute to stray animal care in the town and state and support the State Veterinarian Laboratory in Augusta as well as Maine State Humane Agents who investigate animal abuse cases.

If you have lost your dog, you can call Raymond Dispatch at 655-7851 or the Town Office during business hours, and they will notify our Animal Control Officer.

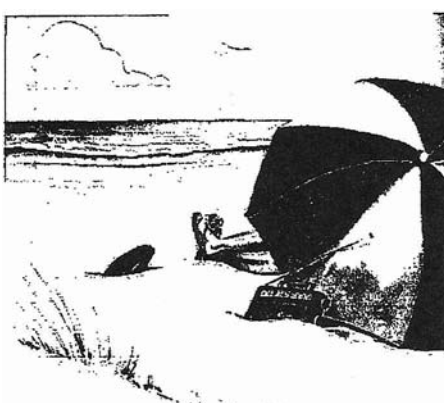
## Tassel Top News

## RES Principal's Report

I think that students and teachers alike at RES are happy that March is finally over and that spring is finally here. It was a very busy month at the elementary school, with MEA's administered in grades 3 and 4, a snow day to start the month, and a number of bitter cold days that meant inside recess. I want to congratulate the children for continuing their great work, positive attitude, and wonderful efforts each day. The move to an earlier Daylight Savings Time, the warmer temperatures, and the increasingly sunny days have given each of us a great boost as we head into April.

Last year we implemented the Everyday Mathematics program in grades K – 6. The program takes a very hands-on approach to teaching math concepts, and teachers are working very hard to adapt the program to meet the needs of all learners using this program. This year I am observing all of the math classes in grades K – 4 in order to build a greater understanding from the administrative perspective, and to support the continuing efforts to improve math instruction at the elementary level. In each of the classrooms that I have visited I have seen a high level of engagement for all of the children. At the kindergarten level the children are using games, such as Disappearing Train and Money Cube, to develop the concepts of addition and subtraction, regrouping, and counting by 2's, 5's and 10's. When visiting the second grades, I observed the students collecting data using their arm spans and then results from long jumps to find the median, create a scatter plot, and finally graph the data. First graders were introduced to comparing numbers using > and <, and applying this skill to a favorite game, Top It Addition. This second year of the program is going much more smoothly as everyone, teachers and students, are more familiar with the vocabulary, math language, and routines and procedures embedded in Everyday Mathematics. I am very pleased with this choice of math programs and excited to have a consistent program in place for grades K – 6.

I encourage all parents to integrate math into their daily lives by looking for fun opportunities for your children to count, sort, group, and use numbers in meaningful ways. And as always, I ask that parents and children spend time each and every day sharing the joys of reading together.

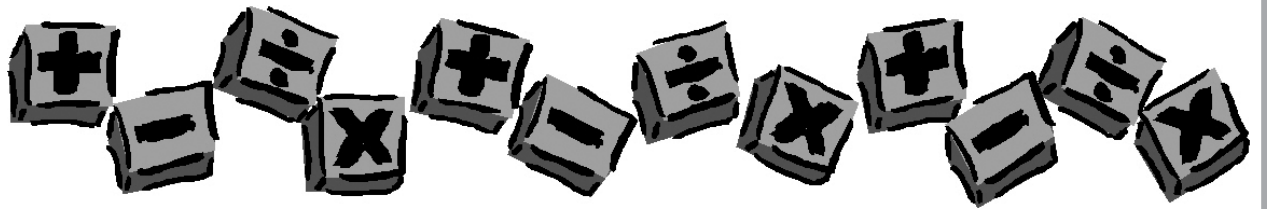

## PTO News

### Request for Funds

At our March 13th meeting we voted to support a request to help fund Raymond students in the Windham High School band who are going to New York City to participate in an international music festival in April. Seven of the 36 band members attending are from Raymond, and they need to raise approximately \$650 per student. Those present felt it was important for the PTO to continue supporting our Raymond students throughout their high school years. We agreed to give each of our students \$100 toward their trip. By supporting this project it helps us to fulfill our mission of enriching educational programs.

We also agreed to give the Wellness Committee \$250 toward the purchase of sun safety items such as water bottles, visors, t-shirts and lip balm. Jerilyn Ward, the school nurse, has received a \$500 Sun Safety Grant, which was used to purchase two portable shade structures for the school. A stipulation of the grant requires an educational segment. In May, a Sun Safety Day will be held where the children will practice sun safety all day. The items purchased with our donation will be given out that day. By supporting this project it helps us to fulfill our mission of collaborating with community organizations.

The Title One Program was granted \$75 for incentive prizes. It is holding a reading incentive program, which will track the reading minutes of the children and offer incentive prizes to the top three students each month between February and June. The money will be used to purchase 15 books as well as gift certificates to a bookstore. By supporting this project it helps us to support faculty and staff in the work that they do.

## Compost Bin Order Deadline April 2nd

You have until April 2nd to place your order for the Maine Resource Recovery Association compost bin. Orders will be taken at the Town Office at \$39.50 each (tax included). Checks should be written to "MRRA" (Maine Resource Recovery Association).

These bins have a 10-year warranty and are made of 100% recycled black plastic. They are approximately a 40-gallon size, 35" high and 33" wide. It is estimated that Raymond residents can save \$138 for every ton of waste they compost.



Again this year a covered kitchen scrap pail is also available for \$10.50. Both these items are displayed at the Town Office and Village Library. Deadline for orders is April 2nd.

These bins and pails will be available for delivery on or about May 10th.

## Raymond Hosting Compost Bin Sale

The Town of Raymond is planning to hold a backyard "Compost Bin & Kitchen Waste Pail Sale" for Earth Day 2007.

Are you tired of seeing all of those kitchen leftovers from preparing meals and snacks get thrown out in the trash or eaten by critters in your makeshift composting bin in the backyard? Here's your chance to turn those scraps into a rich soil amendment.

As part of Earth Day 2007 celebrations, Raymond is participating in a statewide backyard composting bin sale. Through April 2nd, 2007, a home compost bin and how-to guide with a combined retail value of \$80 can be purchased for only \$39.50 (tax included). The bin is black, has a 10-year warranty, and is made of 100% recycled plastic. It's approximately 35" high and 33" wide, or large enough for the composting needs of a family of five. Kitchen Waste Pails, for all your kitchen food scraps, are also available for sale at \$10.50 each.

It's estimated that 25 percent of the average household's waste consists of yard trimmings and kitchen scraps, which can be easily composted. Raymond's residents can save money for every ton of waste they compost because it is not shipped out of town for disposal.

## April 1st Deadline for Property Tax Exemptions

The Town of Raymond and the State of Maine provide the opportunity for residents to get certain exemptions from the property tax. These exemptions represent a certain amount of value, which will be subtracted from your total real estate property valuation. The values may vary from year to year. If you qualify, the exemption(s) will apply to the 2007-2008 tax year.

- **Homestead Exemption:** If the owner is a legal resident of Raymond, come to the Town Office and fill out an easy one-sided application.
- **Veterans Exemption:** If the owner is 62 years of age by April 1st, a veteran of a federally recognized war period, and can provide an honorable discharge DD214, come into the Assessing Office and apply.
- **Blind Exemption:** If the owner is legally blind and can provide a note from his/her doctor stating that fact, come into the Assessing Office and apply.

## Raymond School Department Wellness Committee

The state has required that each Maine school district adopt a Wellness Policy by September 2006. This policy focuses on student wellness education, monitors that school meals meet federal law standards and provides nutrition guidelines for all foods available in each school building. It also includes the state-mandated restrictions of selling soda and other foods that do not meet nutritional guidelines.

The Raymond School Department Wellness Committee has been appointed by the School Board to address student wellness issues and is responsible for making recommendations related to the wellness policy, wellness goals, administrative or school regulations and practices, and raising awareness of student health issues. Our focus has been on educating students, staff, parents and the community on the wellness policy, and our goal is to promote healthy lifestyles. The committee meets regularly to discuss and implement ongoing improvements to the school lunch program, school based activity programs and wellness education.

Our school lunch program has made several changes as a result of this policy. One is the use of whole grain products and low fat cheeses. RES has initiated a 'no thank you' portion, where students are given a very small amount of the food they wouldn't usually try. This has allowed students to expand the variety of foods they eat. At JSMS, the popular salad bar is in full swing three days a week.

A refrigerated vending machine has been purchased for JSMS and is stocked with healthy snack alternatives that are available throughout the day and after school. There is always water available for those students who have forgotten their own water bottles at home or are in need of a hydration boost. In addition, our JSMS 6th grade classes are benefiting from a 'Maine-ly -Nutrition' granted program. Ms. Patricia Feeny and her students are exploring all aspects of creating a healthy lifestyle.

Physical activity at RES is being addressed through the established 'take time for exercise' program. This program introduces 10-20 minutes of daily physical activity within the classroom that can be incorporated into a lesson plan or a scheduled activity break. After-school activities include many of our granted SEARCH programs, such as ice skating or pillo polo. At JSMS we are presently supporting outdoor recess activity for all grades. Parent volunteers are assuring a time of outdoor activity for grades 7 and 8, while grades 5 and 6 have recess time built into their schedules. After-school sporting activities are ongoing at JSMS, and all students are encouraged to participate.

The Wellness Committee is also actively implementing the 'Sun Safety' grant at RES to educate students and staff about skin cancer prevention. The grant will also provide funding for two portable shade structures that will protect students from the sun during outdoor activities.

Future planning includes the possibilities of establishing a school based Health Fair, inviting speakers to present on health/wellness issues, creating activity-based events and assuring the ongoing education of student health concerns.

## Raymond-Casco Historical Society

The Raymond-Casco Historical Society welcomed Anthony Appa, archaeologist from Ipswich, Mass, to their recent March meeting held at the Casco Public Library. He had come across a family Bible as he was browsing in an old bookshop in Boothbay Harbor. He discovered that it originally belonged to a family living in Raymond, Maine. He found the Raymond-Casco Historical Society on the Internet and contacted Laurie Cook, RCHS Historian. He wanted to return the Bible to its original family, the Edward Files Family of North Raymond.

The Bible was published in 1852 by Carlton & Phillips in New York City. It is a family Bible that was well used and records the births, marriages and deaths of the Files family. It is an American Edition of the Revised Version of the English Bible and bound in grained leather.

Mr. Abba has completed extensive research since finding this book in 1976. All his research has been well documented and was presented together with the family Bible to the Raymond-Casco Historical Society for safekeeping and for future generations to enjoy. Abba, wearing white gloves, carefully showed special pages of note to RCHS members. He then gave members sound advice about the importance of conservation, preservation and information on archival storage boxes and climate-controlled cabinets. Members were appreciative of his efforts to return the Bible to the family and to RCHS. His advice was especially welcome as members plan their future museum, which will be open to the public and will include a room for genealogical research.

Betty McDermott, a former Raymond selectwomen, is a direct descendant of the Files family. She is also the treasurer of the RCHS. Betty was especially delighted to receive the Files Family Bible and is delighted that it will be part of the RCHS collection. Her cousin, Raymond resident Dana Files Rand was also at the meeting. Of added interest, a John W. Files of Gorham seeing the announcement in the previous

week's newspaper came along with considerable research he has conducted on the Files family over the years!

Betty and John had not met before so it was a joyous occasion as the two families exchanged stories. A William Files, at nine years old, was a stowaway on a ship out of England in 1737. After his marriage, the couple settled in Gorham. Maine branches of that family then took the steamer out of Standish, crossed Sebago Lake and landed in Raymond, where the Edward Files family homesteaded on the North Raymond Road. RCHS members really enjoyed meeting with Mr. Abba, who had traveled to Casco just to deliver his Bible to its rightful owners, the Files family of North Raymond.

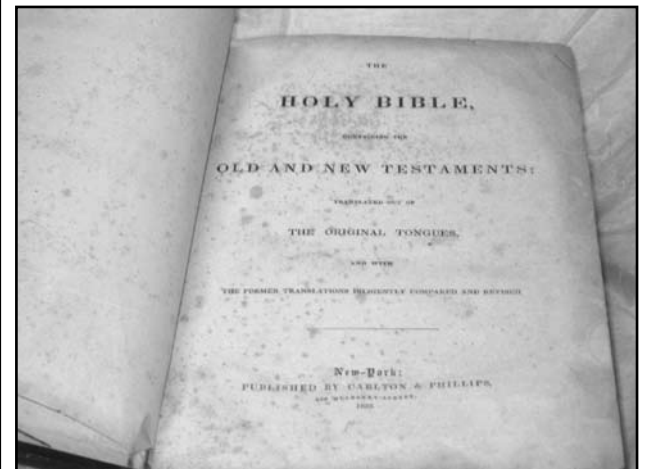

**Legislative Update**

Rep. John C Robinson



As the First Regular Session of 123rd Maine Legislature picks up momentum, I wanted to take a moment to update residents on a number of bills I have sponsored:

L.D. 82, "A Resolve, To Create a Study Commission To Evaluate the County Tax Structure" - This resolve proposes to establish a study commission to evaluate the county tax structure as it relates to property valuation. The goal of the study is to construct a solution that would uncouple the county tax base from property tax and land valuation. The study commission will examine different ways to assess county taxes, including, but not limited to, assessment based on the population or on consequential services rendered.

L.D. 270, "Resolve, Establishing the Task Force To Eliminate Outdated or Unnecessary Laws and Rules To Stimulate Job Creation" - This resolve proposes to create a task force composed of members of the small business community. The task force would be required to examine laws and rules relating to the regulation of small business and report back to the Second Regular Session of the 123rd Legislature with recommendations to alter or eliminate those laws or rules that are unnecessary or outdated. This was a bill brought forth by the New England Small Business Advocate during testimony before the Business Research and Economic Development Committee during the last Legislature.

L.D. 1434, "An Act To Lower Maine Income Tax Rates" - This bill decreases the top two income tax rates over a 4-year period, beginning with tax year 2007. The initial decrease is from 8.5% and 7% to 8% and 6.5%, respectively, and then a further 1% and 0.5% decrease in each rate, respectively, for the 2008, 2009 and 2010 tax years until both rates are 5%.

L.D. 1614, "An Act To Transfer All Registry of Deeds and Probate Functions to the Secretary of State and Courts" - The purpose of this bill is to transfer the functions of the county register of deeds offices to the Secretary of State, and to transfer the functions of the county registers of probate to the office of the clerk of courts as a first step toward greater regionalization of services, reduction of costs, and ultimately would result in property tax relief.

I stand firm in my commitment to ensure your tax dollars are spent wisely. Upholding that principal is my intent in sponsoring these pieces of legislation.

Then there's MARVEL, an astonishing collection of databases and full-text articles from hundreds of journals, newspapers and magazines. Drop by for a demonstration and instructions on how to use this incredible resource right from your own home computer!

The ALA reports that library use remains steady, and is even increasing, in spite of all that the Internet offers. This bodes well for an institution designed to offer equal access to information, as well as one that reflects the vitality of a community.

## Rep. John Robinson Announces Maine Moose Hunt Application Deadline

AUGUSTA – State Representative John Robinson of Raymond is reminding local hunters to file their 2007 moose permit applications with the Department of Inland Fisheries and Wildlife soon, as the application deadline is fast approaching.

The Department of Inland Fisheries and Wildlife will not accept applications received after 4:59 pm on Monday, April 2nd, and all applications must be made on the Department's standard application form. The public chance drawing, also known as the Moose Permit Lottery, will be conducted in June by the department.

All applicants 16 years of age and older must comply with Maine's hunter safety law before a big game license can be issued. Additionally, anyone receiving a Maine moose hunting permit must wait two years before being eligible to hold another one. Hunters who received permits in 2005 or 2006 may not apply this year. This requirement affects permit holders only. It does not affect hunters who were subpermittees, nor does it prohibit a hunter from being a subpermittee during the two-year waiting period.

Maine will have two different moose hunts this year: Sept. 24 - Sept. 29 in Wildlife Management Districts 1-6, 11 and 19, and Oct. 8 - Oct. 13 in Districts 1-14, 18, 19, 27 and 28.

Applicants will not have a choice of a hunting week, and applicants must mark zones on the application in order of choice. If the hunter wants a chance to hunt moose in a specific month, the application must list the Wildlife Management Districts that allow hunting during that month.

As a reminder, Raymond provides curbside household trash pick and recycling. Pine Tree Waste is our contract trash hauler. If you wish to call them about an issue, their phone number is 888-857-0800. If you have any complaints, you can call them directly or call the Town Office at 655-4742 ext. 21. You can also e-mail me with complaints or suggestions at [louise.lester@raymondmaine.org](mailto:louise.lester@raymondmaine.org). Your day of pickup for the western and southern parts of town is Tuesday and the northern and eastern parts is Wednesday. If you have a question about your day of pickup, please call the Town Office or look at the map on our website [www.raymondmaine.org](http://www.raymondmaine.org).

Each household is allowed two 32-gallon containers (each not more than 50 pounds) per week. It is necessary that you have your street address on your trash barrels along with an orange sticker which you can get at the Town Office free of charge. You can recycle as much as you wish. A list of recycling items is available at the Town Office, as are blue recycling bins for \$6.15 each. If you have more than the two 32-gallon containers for a week, there are bag stickers for sale at the Town Office for \$1 each. You may put out as many stickered bags as you wish. All trash and recycling must be curbside in barrels by 7am on the day of pickup.

### 2006 Is A Good Year For Deer Hunters

Despite a rainy and windy opening day to the deer season, hunters fared a little better than expected last year during the deer season, with 29,918 deer killed. The number is slightly above the 29,400 pre-season prediction, and also above the 20 year average of 28,700.

“While the season may have started a little wet, I am pleased to see that so many hunters persisted and were rewarded with success this past season,” stated Martin. “I am also thrilled to see that so many young hunters were successful on youth day. Passing along a tradition such as deer hunting is a wonderful way to teach a young hunter values such as conservation, responsibility and ethics.”

Maine’s deer season stretches from September through December, and is broken into several segments that includes the Regular Firearms Season, the October Archery Season, the Expanded Archery Season, the muzzleloading season and youth deer hunting day. The total deer kill for each of the past ten deer seasons is as follows: 2006 – 29,918; 2005 – 28,148; 2004 – 30,926; 2003 – 30,313; 2002 – 38,153; 2001 – 27,769; 2000 – 36,885; 1999 – 31,473; 1998 – 28,241; 1997 – 31,152; 1996 – 28,375; 1995 – 27,384.

Youth hunters had their best day ever, as 1,216 young hunters were successful that day, nearly twice the total of last year’s 672 successful hunters. Bowhunters and muzzleloaders also found more success this year compared to last. 2,494 deer were taken during the expanded and October archery seasons. Muzzleloaders took 1,307 deer, up from the 994 last year.

More deer were killed in Penobscot county (3,509) than in any other county this past year. Other counties where more than 2,000 deer were killed include Somerset (3,472), Kennebec (2,920), Cumberland (2,677), York (2,580), and Oxford (2,240).

Hunters this year killed 16,081 adult bucks, and 13,798 antlerless deer. The antlerless kill of 13,798 was very close to the predicted antlerless kill of 13,510. This year, the department issued 67,725 Any Deer permits. An Any Deer permit allows a hunter to harvest a deer of either sex. By controlling the number of female deer in a population, the department can manage deer population trends. Any Deer permits are issued through a lottery system.

Department of Inland Fisheries and Wildlife Biologists have been monitoring the effects of this year’s winter on the deer population through weekly checks at weather collecting stations at 28 locations throughout the state. Each week, biologists visit these stations to record data. The data is compiled and compared to past years to determine the severity of the winter and what its impacts are on the deer population in different areas of the state. This data is used in determining how many any-deer permits will be issued for next year. IFW wildlife biologists will be meeting in the next few weeks to determine the number of any deer permits that will be available for next year.

Overall 71% of the deer registered were by residents. Estimates of success vary, with resident (including landowner) any-deer permit holders having a 26.8% success rate overall versus 22% for non-resident hunters. In general, buck hunters without an any-deer permit harvested bucks at an estimated 10-12% success rate.

Maine’s statewide post-hunt population was estimated at 218,700 deer or 7.6 deer / mi<sup>2</sup> during 2006. For 2007, deer population management will continue to focus on increasing the number of deer in the northern and downeast regions. And with a relatively moderate 06’-07’, winter doe harvests will likely continue at similar levels in order to stabilize deer populations and maintain our short-term population objectives within most central and southern WMDs.

### Ice Fishing Report, Region A- Southwestern ME

The big event in Southern Maine this weekend was Sebago Lake Rotary Club’s Derby Fest. Two of the most popular events in connection with the Derby Fest are also the one of greatest interest to Region A’s fishery division, namely the kids only derby held at the outlet of Thomas Pond this past Friday and the Sebago Togue Tourney held over the weekend. The kids only derby was a huge success with an estimated six to seven hundred kids participating. The Rotary club gave away 500 traps and volunteers from all over were on hand to coach the kids in their use. The participants caught a number of stocked brook trout as well as a number of warmwater fish. The event was such a success that many kids and their families were still fishing Thomas Pond outlet two days later. Thanks to the Rotary Club for doing such a great job getting kids hooked on fishing!

The Sebago Lake Togue Tourney was once again mobbed with participants, and the togue I observed at the Raymond weigh in station appeared to be in great shape. The catch of togue seemed to be much lower than in past years which is likely attributable to a lack of ice on the big bay eliminating access to some of the best fishing areas and to an abundance of forage fish which may be competing with angler’s bait for the attention of the coveted togue. Derby winners included Greg Mackintosh in third place at 7.34 lbs, Gary Parlin in second place at 8.11 lbs, and Michael Hemmingway in first with his 9.09 lb togue.

Weekend creel census indicated that anglers were still targeting many of the small to medium trout ponds in the northern portion of the region. The anglers I spoke with simply preferred a quiet day on the ice to the city life that was Sebago Lake this weekend. While a good portion of anglers interviewed this weekend reported slow fishing, I did speak to a guy that limited out around noon with a pair of 15-16 inch brookies on Keoka Lake in Waterford. Also reported was a limit of 12-14 inch brook trout on Thomas Pond in Raymond.

Having reported on all the fun fishing over the weekend, I now have to report a bit of bad news. This past Friday I confirmed two northern pike from No Name Pond in Lewiston. This confirmation was a result of an alert angler calling Operation Game Thief (1-800-alert-us, thanks Nathan!) and resulted in the observation of what appeared to be two different age classes of pike. Because we are unfamiliar with the nature of the outlet of No Name Pond it is unclear if the introduction was the result of upstream migration from the Sabattus River or the result of a direct illegal introduction.

Best of luck in the last month of hardwater fishing!

## Registering Boats Requires Milfoil Stamp

The Maine Department of Inland Fisheries & Wildlife is continuing the milfoil stamp program on all motorized boats that will be using Maine inland waters. This money will be used for programs to study and prevent the water plants, including milfoil, from permeating Maine fresh waters. The Eurasian milfoil plant is an invasive plant that eventually chokes freshwater lakes, ponds, and rivers. Once established in a lake, it can become impossible to control. Maine is trying to keep milfoil and other invasive water plants from its waters, and this program is trying to keep our lakes, ponds, and streams from getting it. For anyone with a non-motorized boat who wishes to participate, the stickers are also available at the usual cost.

Part of the ongoing program in Raymond is supporting rangers, either paid or voluntary, who check boats being launched into our lakes. The major way that invasive water plants get into our lakes is by the plant being transported on boats, motors, and boat trailers. When you register your boats, the regular fees will be charged, but in addition a \$10 fee will be charged for residents (boats registered in Maine) and \$20 for non-residents (boats registered out of state).

## Rural Mailboxes Damaged

It has been reported that some rural mailboxes have been damaged by vandals. The Raymond residents who have had to repair/replace their mailboxes have asked that the following information be published in the Road Runner.

“Rural mailboxes are considered federal property, and federal law (Title 18, United States Code, Section 1705) makes it a crime to vandalize them or to injure, deface or destroy any mail deposited in them. Violators can be fined up to \$250,000 or imprisoned for up to three years for each act of vandalism.

Postal Inspectors recommend these actions to protect your mailbox and any mail that may be inside it.

- Immediately report theft, tampering or destruction of mail or mailboxes to your local police. You may file a PS form 2016, Mail Theft and Vandalism Complaint, through your local post office. This form will help the Postal Inspection Service determine whether your problem is isolated or one frequently experienced in your neighborhood.
- Obtain Label 33 from your local post office and affix it to your mailbox. The sticker warns that willful damage to mailboxes and theft of mail are crimes.
- Keep your mailbox in good repair, and make sure it’s properly installed. This may help prevent theft of the mailbox itself.

Remember, if you suspect vandalism, report it to your local authorities. With your help we can make a difference in reducing these acts of crime.

## Town Nomination Papers Available

The 2007 Annual Town Meeting will be Saturday, May 19th, at 10am at the Jordan-Small Middle School gymnasium. On Friday, May 18th, our Town Elections will take place at Jordan-Small Middle School gymnasium from 7am to 8pm. The positions that will be available for candidates are Budget/Finance Committee 3 seats, School Committee 1 seat, and Selectmen 2 seats.

The Budget/Finance Committee reviews the Annual Town Budget, with its primary “season” being from January into March to be ready for the Annual Town Meeting in May. Usually the Committee meets twice a month during those months and during the rest of the year as needed. The School Committee has two regular meetings a month, and the Selectmen also have two regular meetings per month.

If you wish to run for an office, please obtain a nomination form at the Town Office during regular office hours beginning February 23rd. You will need to obtain not fewer than 25 but not more than 50 Raymond registered voter signatures. The deadline for submitting the completed nomination form will be Wednesday, April 4, 2007, at 4pm.

## Cardboard Recycling

The Town of Raymond recycles corrugated cardboard at the District II Fire House/Public Works Garage on Webbs Mills Road. Because of limited space, it is imperative that you break down the boxes left at the site. If you leave the boxes without breaking them down, you may be charged with littering.



### Inhalant Abuse Awareness

What is inhalant abuse? When most people think of someone using drugs or getting high, they tend to think of a stereotypical character that they have seen portrayed on TV and in the movies. Sometimes these stereotypes are accurate, but other times they are simply dramatizations. The truth of the matter is that drug use/abuse can happen in every home that has a garage with chemicals, a kitchen or bathroom with cleaning products, or even a home supplied with average household writing implements.

What are these chemicals that are so easily available within the home but that go unnoticed? **Solvents** such as paint thinner, gasoline, and other volatile chemicals often found in a garage. **Aerosols** such as spray paint, computer cleaner, over cleaners, and hair spray. **Gases** including nitrous oxide found in whipped cream cans; often referred to as whippets.

Essentially any household or industrial chemical can be used to get high, and the consequences to a person's health from ingesting these compounds can be extremely adverse. "Sudden sniffing death" can occur the first time an individual uses certain chemicals to get high. A few of the potentially

lethal ones are butane, propane, and the various chemicals found in aerosols. Long-term effects of inhalant abuse can be liver and kidney damage, psychiatric issues, and central nervous system damage, in addition to various other health related problems.

According to the 2002-2005 National Surveys on Drug Use & Health, the annual average number of new users of inhalant-type substances was 600,000 adolescents between the ages of 12 and 17. Females accounted for approximately 11,000 more users than males. The majority of these children trying this form of intoxication were predominantly white, 14-15 years old, and of average income. Small cities and suburbs, including rural suburbs, accounted for approximately 50% of the teenagers using inhalants.

This is an issue that everyone can and should do something about because it is so easily accessed through everyday products found in your home. Talk to your kids about the risks of using drugs – and do so often. Don't forget that your kids will be offered to get high more than just one time. And if you suspect your child is using an inhalant or other "recreational" drug, know that there are licensed alcohol and drug counselors ("LADC") who specialize in adolescent/young adult treatment and can recommend the best course of treatment for your child.

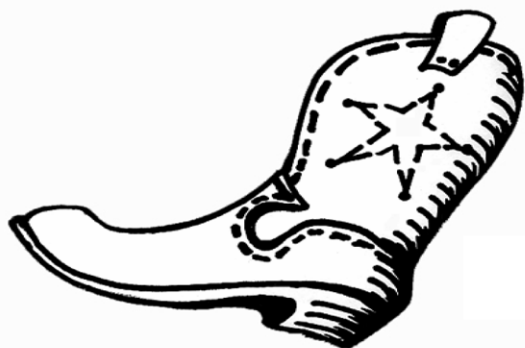
